


"Love in the Time of COVID-19": Some Tips to Help with "Social Distancing"

Health officials are advising us to stay away from in-person gatherings and to practice "social distancing" as a means to slow down the spread of the COVID-19 virus. There are many ways to connect safely with one another, and build community creatively; and we can also do some "traveling" while remaining safely at home. You're invited to share **your** tips on our social media pages!

- If accessible to you, take a walk, roll or stroll, in an area with plants, trees, and fresh air. Invite a distant friend to do so at the same time, and share photos with one another of flowers and things you see by texting on your smartphones.
- Ask a friend to do 5 minutes each morning and 5 minutes each evening of meditation and sharing of spiritual texts or quotations by phone or videoconference. (Some EBMC Sangha members are doing this now; it's a beautiful, stabilizing, and calming practice.)

"May I Be a Protector to Those without Protection"

A total of seventy-four members of the EBMC Sangha have now received Bodhisattva Vows and Precepts, in the first ceremony offered at the Center in December 2017, and more recently in December 2019. Two members of the 2017 cohort renewed their Vows in 2019 by participating in the ceremony. Recalling the words of the great Buddhist teacher Shantideva, these Dharma practitioners have promised, "May I be a protector to those without protection" — in fulfillment of the joyful desire to encourage and accompany all living beings on the journey of awakening.

EBMC: Hi Irene and Antoinette, what brought you to EBMC, and could you tell us a little more about yourselves?



Irene Ross:

I was born in Oakland and first began practicing meditation when I was a teenager. Many years later, I connected with EBMC through the Alphabet Sangha and later participated in the White Awakening in Sangha (WAS) yearlong program. I was drawn to EBMC because of the Center's commitment to fostering a socially engaged and radically inclusive Sangha.

Antoinette González: I checked out EBMC before I even moved to the Bay Area several years ago. When I lived in Fresno, I drove up a couple of times to participate in several daylong practices. Once in the Bay Area, I felt very fortunate to regularly attend the weekly POC (People of Color) Sangha and Yoga practice gatherings. I have come to deeply appreciate socially engaged Buddhism and the active work of inclusivity embodied at EBMC.



I grew up in a mixed legal status home in Fresno, was raised Catholic, and I identify as a queer Chicana/Latinx.


EBMC: Antoinette, we're particularly interested in the work you've done in helping undocumented immigrants in the U.S. Could you tell us a little more about this?

Antoinette: I began serving immigrants while in law school, working with a San Diego organization that served detained and non-detained immigrants seeking asylum. I have given multiple Know Your Rights presentations, especially when they were in demand after the 2016 elections. More recently, in workshop settings, I have offered free legal services to undocumented immigrants seeking help and information about their options to remain in the U.S.

EBMC: Irene, we're particularly interested in the work you're doing as an attorney working with immigrant people who are seeking asylum in the U.S. Could you tell us more about this?

Irene: I currently represent LGBTQQII asylum seekers who are facing persecution in their home countries on account of their sexual orientation and/or gender presentation. A grant of asylum gives an individual the right to live and work in the United States. Asylees can later apply to become lawful permanent residents and U.S. citizens.

EBMC: What are the top 1-3 things you think the Sangha needs to be aware of regarding



the current immigration laws and realities, and do you have any action recommendations or names of organizations that are doing particularly good work?

Irene: Asylum seekers need access to interpreters, attorneys and sponsors in order to have a fighting chance at winning their case. The U.S. Government does not provide court-appointed attorneys or interpreters to asylum seekers who cannot afford them. There are many wonderful groups who are working double-time to offer those services and there is still a huge need for skilled volunteers. Antoinette: First, chaos, fear and trauma is this administration's strategy in targeting immigrant (documented and undocumented) communities. Seek out places of support, including legal resources. The Bay Area has many legal resources, more than other regions. Second, most immigrants (undocumented and documented), unfortunately, do not have access to legal representation. This negatively affects an undocumented immigrant's ability to have a meaningful opportunity to make a claim in immigration court or file a petition/application with USCIS (U.S. Citizenship Immigration Services). Legal representation should/must be provided, at a minimum, to children under the age of 18. Third, immigration policies/laws change continuously. Seek out legal assistance from accredited representatives or immigration attorneys and not from notarios/notaries.

We are the necessary resilient communities for each other. Creativity in advocacy, legal representation and lifting up immigrant communities is urgently needed! Here's a list of recommended resources:


